BUSINESS TRIP TO ETHIOPIA

29 September – 03 October 2014

Swiss-Ethiopian business relations

Switzerland is Ethiopia's 6th most important trading partner. The volume of Switzerland's bilateral trade with Ethiopia reached 183m CHF in 2013, according to figures from the European Union. Swiss imports from Ethiopia totalled 139m CHF, whilst exports stood at 44m CHF. For the same period, and without taking into account gold, the Swiss statistics show exports to Ethiopia of 33m CHF and imports of 30m CHF.

Switzerland's main exports to Ethiopia are pharmaceuticals, machinery, vehicles and to a lesser extent, watches. Imports from Ethiopia consist primarily of gold and raw materials from agricultural production (mainly coffee, and to a letter extend oilseeds and flowers).

Ethiopian economy

With a population of over 93 million people (2nd most popular African country, behind Nigeria and ahead of Egypt) and a growing middle class, there is a demand for manifold products and services in Ethiopia. The average annual growth rate between 2003 and 2012 was 11% and today stands at still impressive 9.7%. This makes Ethiopia the 12th fastest growing economy in the world.

In terms of total GDP (PPP), Ethiopia is with 123bn USD the 7th biggest economy in Africa. The GDP per capita of only 1'309 USD however is well below the African average (note: according to a recent study from PwC, the GDP per capita in the capital Addis Abeba is up to six times higher than the national average).

The economy of Ethiopia is based on agriculture (Ethiopia being one of the most rural countries in the world), which accounts for over 40% of the economy, 60% of the exports and 80% of the employment. In recent times the services sector has overpassed the agriculture sector and accounts for 45% of the country's GDP, well ahead of the industry sector which contributes 10% to the GDP. Although manufacturing (mainly food and beverages, textiles, leather) has shown some growth and diversification in recent years, much of it is concentrated in Addis Abeba and its surroundings.

Over the last few years, Ethiopia has been carrying on an ambitious reform agenda. The main instrument of the governmental economic planning is the "Growth and Transformation Plan", which covers the period 2010-2015 and includes massive infrastructure investment projects throughout the country.

Addis Abeba – the diplomatic capital of Africa

With a population of +-3.3mio inhabitants, Addis Abeba is Ethiopia's capital and largest city. Addis Abeba hosts the headquarters of the African Union, the United Nations Economic Commission for Africa (UNECA) and many other continental and international organisations.


